



MCC FAMILY AND STUDENT CONTRACT: 2024-2025 School Year

As'salamualaikum Junior and Senior Families,

This contract is to outline the rules and policies associated with your child attending Middlesex County College classes for the 2024-2025 academic school year.

The Dual Enrollment Program at Middlesex County College is a huge asset for students as they are able to acquire College Credits while still continuing their high school education. Students can graduate high school with an average of 26 college credits!

Parents are encouraged to frequently check on their child's progress by looking through their Canvas account. It is important to remember that college credits will only transfer if students receive an "A" or a "B" in the class and in some cases, a "C". Colleges will not accept a "D" or "F" grade to be transferred. Additionally, when applying to colleges, students must be aware that their college application will be unfavorable if they have a "D" or an "F" on their transcript. Being a part of the Dual Enrollment Program is a privilege that we offer students at Pillars Preparatory Academy. With privilege comes responsibility.

The following is a list of guidelines all students/families must abide by:

- **Family Financial Responsibility**

- **Pillars will pay the In-county cost for all students for Fall and Spring semesters only.**
- **Residents outside of Middlesex County** are responsible for the out-of-county tuition fees for Fall or Spring semesters. This totals to about **\$2,200- \$2,500 per semester.**
- **Students who receive a "D" or an "F"** in any course at Middlesex County College. Families will be responsible to pay the full cost of the course.
 - Middlesex County Residents: Totals to **about \$270 per semester**
 - Out-of County Residents: Totals to **about \$2,200 - \$2,500**
- **Winter and Summer Semesters** are optional and are the full financial responsibility of the family.
 - Middlesex County Residents: **about \$270 per semester**
 - Out-of County Residents: **about \$2,200 - \$2,500**

- **Behavioral Expectations**

- Students are expected to:
 - Abide by the Pillars Prep Academy Student Handbook Code of Conduct and Rules at all times, even when on Middlesex County property.
 - Attend all their MCC classes, on time and in their entirety (no leaving early).
 - Not leave MCC campus for any reason.
 - Respect and listen to the driver responsible for transporting students to and from MCC.

- **Class Choices**

- **Students are not allowed to Drop a class for any reason.**
- If students are having concerns about a course, they can speak with the Guidance Counselor and/or the MS/HS Department Head to see if they can come up with a solution.
- Students may speak with the Guidance Counselor and/or the MS/HS Department Head about specific **future** course requests they would like to take. Although, this needs to be done well in advance of the start of the new semester.
